GUEST JUDGING PROCESS

In a spirit of cooperation and good will which has developed over many years between the various registering bodies, we have discovered that shared judging expertise can often provide many positive benefits. The CFA Judging Program offers our esteemed Judging Panel to other associations, and we welcome guest judges from those associations. We are proud to present our Guest Judging Process.

Non-CFA Judges requesting permission to guest judge CFA shows:

Any Approved Specialty (longhair or shorthair), or Allbreed judge may accept a judging invitation from a CFA club if their governing body is a member of any of the “Approved Foreign Associations” and/or clubs listed below. Any CFA club inviting a non-CFA judge must contact the International Judging Program Administrator for permission, and provide the following information:

- Judge Name
- Judge’s Affiliated Association
- Name of club hosting CFA show
- Location of show
- Date of show

CFA Judging Contracts must be used. Once a contract is signed by the Judge and the club, a copy is forwarded to Central Office at the time the show is licensed with CFA.

CFA Judges to Judge International Assignments:

Any CFA-licensed Approved Specialty (longhair or shorthair), or Allbreed judge may accept a judging invitation from an Approved Foreign Association. The CFA judge must contact the International Judging Program Administrator with the following information:

- Judge Name
- Invitation from Affiliated Association
- Name of club hosting show
- Location of show
- Date of show
